## Legislative Task Force Formed at Recent Governmental Affairs Workshop

LATA hosted a Governmental Affairs Workshop prior to the recent summer symposium. The workshop was led by **Gerard White** (LATA President), **B.J. Duplantis** (LATA Governmental Affairs Chair), **Judy Pulice** (NATA National Manager, State Legislative & Regulatory Affairs), and **Iva Thibodeaux**. During this workshop, members discussed the legislative process, the history of the Louisiana Law, recent legislative items affecting athletic trainers, and the future direction of the legislative agenda for athletic trainers in the state. The organization decided to create a legislative taskforce to form a unified direction for future legislative sessions. The taskforce members should be named by July 1, 2012.

## Executive Committee Seeks Feedback on Consensus Statement

During the summer general business meeting in Monroe, the Executive Committee discussed their support of a statement designed to help the various orthopedic health care providers to better understand the value of the certified orthopedic technologist. ## **HCR 69 Filed with Secretary of State**

During the recent legislative session, **HCR 69** by Representative Ligi has been passed and filed with the Secretary of State. This resolution amends administrative rules relative to examination requirements for athletic trainer certification and eliminates the "four strike" policy for state certification. **HB 362 (Act 706)** allows automated external defibrillators (AEDs) in high schools that participate in interscholastic athletics under certain circumstances.
